

W&L Chapel Desecration Update - An Anonymous Letter

Occasionally, we receive letters such as the one below, with no return address or signature. This particular one is so full of misinformation and false statements, that we decided to share it and our reply here, in the hopes that the "anonymous" author, and anyone else who may have been misled, might see it and be educated.

The author's comments are in black, our responses in red...

"I was on the W&L campus this weekend. I saw your people at the entrance to the Chapel lot and I saw the little flyer you were handing out in different places." *Good to hear! Nice work, Flaggers!*

"My great great grandfather fought for the Confederacy and was killed at Petersburg." *God bless him! What SCV Camp or UDC Chapter to you belong to?*

"Yours is a sad and puzzling effort. Let's get the fact straight.

- 1) There were NO flags in the Chapel for 60 years after Lee died, and no evidence that Lee wanted flags there". We are not sure what facts you are "straightening" here. We have never heard anyone claim there were flags in the Chapel before 1930 and do not dispute that fact. You claim there is no evidence that Lee wanted flags there. We assert that there is also no evidence that Lee DID NOT want flags there, despite what the Chapel docents have been instructed to tell visitors.
- "2) The real flags were there for 60 years from 1930 until about 1990, NOT until 2014, as your brochure so incorrectly states." Actually, it was 1995 when the original flags were removed for preservation and restoration, as they certainly should have been, and reproductions were secured and put in their place, as they certainly should have been. Our brochure states that the reproduction flags were removed in July of 2014, which is correct.
- "3) They were removed over 20 years ago by the MOC because they were deteriorating. In their place, W&L got some commercial knock off/replica flags which have no more historical value than something I could buy in an Alabama K Mart." As stated before, we have no issue with the arrangement, made in 1993 between the University, the UDC, and the Museum formerly known as the Museum of the Confederacy, to restore and preserve the original flags. However, you, Sir or Madame, are greatly misinformed if you believe the replica flags that were carefully placed were something that one could purchase at a department store.

As can be seen in the above photo, the flags were custom made to precisely replicate the unit flags that were removed for restoration. They were and are of great "significant historical value", and as the flags of several units who fought under General Lee, completely appropriate as displayed in the mausoleum.

4) W&L has removed these knock offs and is getting Real battle flags on loan from the MOC (now known as the American Civil War Museum). Yes, W&L has removed the replicas, but it has absolutely NOTHING to do with the plan to restore and preserve the original battle flags, which was a

project started by former President Elrod, NOT President Ruscio. Removing the replica flags was NEVER a part of that project, and is completely unrelated. The flags were removed in capitulation to the demands of 6 W&L Law Students who threatened "Civil Disobedience" if the flags were not removed. University officials have used the (1993!) agreement as a smokescreen to cover for this fact, and, apparently there are those like you who have swallowed the spin... hook, line, and sinker.

DID YOU KNOW?

Confederate General Robt. E. Lee



Although highly respected as a soldier with a very distinguished career (He fought valiantly in the Mexican War, led the troops who captured John Brown at Harper's Ferry, and served as Commandant at West Point.), at the time **ROBERT E LEE** was

appointed to succeed the wounded Joseph E. Johnston to command of the Army of Northern Virginia in the summer of 1862, he had never directed a battle. Nevertheless, Jefferson Davis's decision to appoint Lee proved a most wise one. Like Julius Caesar and Napoleon Bonaparte, Lee showed incredible brilliance and daring in his leadership.

One of the most unfortunate opponents Lee faced was Union General Joseph Hooker. Known as "Fighting Joe" among his men, Hooker was much more famous for his amorous exploits with Washington D.C.'s "ladies of the night," who were often referred to as "Hooker's Legions," from which the slang term "hooker" evolved.

UNION GENERAL JOSEPH HOOKER



Like his predecessor, Major General George B. McClellan, being overly cautions proved Hooker's undoing. At Antietam (Sharpsburg) McClellan commanded a force of 75,000 men against Lee's 52.000, yet what should have been a smashing victory for the

North turned into a stalemate because McClellan held 22,000 men in reserve. This happened again at Chancellorsville, where Hooker led a force of over 133,000 men against Lee's mere 60,000 man Army of Northern Virginia. By keeping a force more than half the size of Lee's entire army in reserve and not bringing them into combat, Hooker allowed Lee to gain the advantage on the field and route the Union forces, turning Chancellorsville into a stunning Confederate victory.

Speaking of Antietam/Sharpsburg, at the time of that battle John B. Gordon, who rose to become a famous Confederate general, was serving as a colonel over the "Raccoon Roughs" he had raised from Alabama. Early in the action he received a minor wound when a bullet cut a hole through his cap. Later in the day, often called "America's bloodiest," Gordon was again hit in the head by another bullet and knocked to the ground, where he bled profusely. The future general would have drowned in his own blood had not the vital fluid drained through the hole made by the earlier Federal ball.

HEADSTONES AND CEMETERIES UPDATE Jeremy Elkins

My father chose to be buried in Mount Pleasant Cemetery in Hickory Withe, TN, in Fayette County. It's a beautiful cemetery that is secluded and off the beaten path. It was established in 1820 by the founding families of Arlington and Hickory Withe.

Names like Ivy and Wilson are everywhere. Even the first doctor to set up private practice in Arlington is buried there. His name was Dr. Preston Bone. He also happened to be General Forrest's own physician



who served with the General throughout the entire war. Albert Weber was a Tennessee State Senator who died in office in 1908...he chose to be buried in his Confederate uniform! Peter Cole was a Lieutenant that was killed in the Battle of Murfreesboro and is also buried there.

Every Confederate soldier we could find...from the well known to the lesser known and even to the unknown will be honored. Flags are placed on their graves every holiday that calls for it. But what about Christmas? Now, thanks to the gracious donations from Mary Snipes and Maera Elkins, each veteran has a wreath placed on his grave. Not only the Confederate veterans buried in Mount Pleasant Cemetery, but the unknown Confederate soldiers who lay at rest in Pleasant Hill Cemetery on Brunswick Road. The camp honored them earlier this year for Confederate Memorial Day and we honor them again at Christmas. We may not know their names, but we know their cause that they gave their lives for. May they rest in peace this Christmas and every Christmas forever.





BLUFF CITY GRAYS UPDATE

<u>REPORT OF ACTION FROM THE BATTLE OF</u> SPRING HILL, TN

Following an early morning forced march, we arrived at the Rippavilla Plantation near Spring Hill and met up with our friends from the Cedar Bush Mess and the 32nd Mississippi. Knowing there was a large number of Yankees in the area, we sent scouts out into the surrounding area to gather new recruits, of which we found several - enough to form a battalion and a Color Guard. That done, and the Yankees having been sighted at the top of a ridge, Gen. Forrest's Cavalry engagd the enemy on our left. The artillery opened up shortly after, and we took up position in a long line at the edge of a corn field, with the Cedar Bush on our right, the Grays in the center, and the 32nd Mississppi on our left. From there, we opened fire by platoons within each company, which allowed us to maintain a continuous rate of fire as we advanced. The Yankees advanced down the hill, as we started to take casualties on our right. We had one injury and our Corporal was able to help drag our one injured soldier to safety as two of us covered him on our retreat. He should be considered for a medal of some sort

The losses were heavy on both sides, and we were pushed back but ultimately carried the day. Unfortunately, Gen Forrest reports that the enemy has escaped north toward Franklin. Casualty rand muster eports to follow.

REPORT OF ACTION FROM THE BATTLE OF FRANKLIN, TN

Not an official AAR, but just as an update this month. Bill and Will Rivenbark, Ken Chrestman and myself all overcame a series of personal traumas (I'll spare you the details) in order to get our Blue uniforms on and go to face the Grey Menace at Franklin for the 150th anniversary of that battle. The reenactment was obviously scaled down to size, but was for the most part historically correct. It was much shorter, on a much smaller field, with many fewer men involved. The drone above us shooting video was a bit farby but did what it was made to do, and the Confederates were kind enough to hold their fire long enough to allow us to go put out a small grass fire that was started by a cannon misfire as it was starting to go out of control. As Ken said, "you gotta clean those things, now!". Our friends from Chicago, Co. K of the 154th joined us and together we formed a company of about 16 to 20. Prior to the battle, it had been worked out between us and the field commander to allow us to portray the 36th IL, of Opdyck's Division who had been held in reserve but went without orders to stop the weary, tattered and half starved Confederates who had breached the Union line. This truly was one of the most accurately done, "stick to the scenario and historical facts" events I have been involved in (usually the scenario is out the window with the first shot fired). There were many legitimately interested folks who passed through the camps and asked questions, and the crowd of 5000 seemed to enjoy the "show". The overall event was both elating and saddening from my perspective, and from many of the rest of us as well. Overall, however, this was a GREAT event and if you missed it, well...you missed a good one. It was a great honor for us to be able to participate
